

Taurus - Vrishabh: Moon Sign - Jyotish Forecast for 2016



2016 will bring worries and hassles about health of parents, relations with family members and relatives. The troubles related to property matters, residence and vehicle will also be quite bothersome in 2016 for Vrishabh rashi born people. Marriage and love life will go through extreme ups and downs this year.

HEALTH: Health prospects for 2016 for Taurus or Vrishabh moon sign born people:

The transit of Rahu in fourth house from February onwards and the placement of Saturn in the seventh house whole year will bring increase in both mental and physical health problems for Vrishabh rashi born in 2016. EDUCATION: Education prospects for 2016 for Taurus or Vrishabh moon sign born people:
